

VETERAN DONATION



DON'T BE FOOLED BY AN INDIVIDUAL OR **ORGANZATION WHO SAYS THEY HELP VETERANS!**

It is important to remember that some individuals and organizations ask for donations under the pretense of helping veterans when, in fact, none or very little of the donation goes to veterans. They know that saying they are helping Veterans will increase the likelihood of getting donations because most people want to help Veterans who served their country. Individuals, companies, and organizations that want to donate to help veterans must do their due diligence regarding who they are giving money to! If you are an individual, a company, or an organization donor, check the website of the veteran group before you donate to see if they offer receipts for tax purposes, what percentage of your donation goes directly to help veterans, and if any of the donation goes to pay staff. Donors can also add conditions on their donations, such as x dollars to give a needy veteran a service dog, specialized equipment, or help with food/rent/clothing. Always follow up on your donation to ensure the organization uses your donation as intended.

Donation Abuse Examples:

- 1. Facilities claim to house and serve veterans; however, only a few veterans live in the rooms, and the living conditions are unhealthy and unsafe. Most of the rooms are filled with nonveterans, but by using the word "veteran," they get more funding through donations by individuals and corporations.
- 2. Individuals or companies claim they give veterans big, expensive items if you donate so much money a month. However, only a portion of that monthly donation goes to the veteran, and the rest goes to the individual or company. Do not be fooled by phrases like "95% of your donations go to our veteran programs." That probably means that they are paying their staff to manage those programs, and less of the donation goes to the veteran.

Help prevent veteran donation abuse by researching who you donate to, checking their record of helping veterans, and following up on your donation. Veteran donation abuse does not help the veterans or the donors, and it only helps the individual/company asking for the donation!
